#### Dear Mr. Nemani:

This progress report has been prepared in accordance with Section VI (24b) of the Administrative Order of Consent (Docket Number RCRA-05-2011-0019) entered into by the Revitalizing Auto Communities Environmental Response Trust (RACER Trust) and the United States Environmental Protection Agency (USEPA) for the above referenced Site. The following summarizes the work performed, data collected, estimated percent complete, project schedule, and problems encountered for the period from July 1, 2017 through December 31, 2017 for the portions of the Pontiac North Campus (PNC or the Site) for which RACER Trust is responsible for remediation.

### Work Performed from July 1, 2017 through December 31, 2017

- Submitted Semi-Annual Progress Report to USEPA on July 13, 2017.
- Based on the results of the completed PCB-impacted soil and LNAPL delineation activities, Montcalm seep analysis, and Supplemental Site

Characterization (1,4-dioxane) activities, revisions to the Draft CMS were completed. The Draft CMS was updated and will be submitted to USEPA in February 2018.

- Development of the draft Statement of Basis document began in December 2017.
- Fiero Waste Management Unit inspection site visit with MDEQ was conducted on October 25, 2017.
- Submitted PCB Soil Delineation Scope of Work to USEPA on October 4, 2017. Received approval from USEPA on October 5, 2017. Field work was completed the week of October 30<sup>th</sup>, 2017. Began development of investigation summary, including cross sections of proposed excavation areas, in December 2017.
- Installed signs along the border of the TSCA soil cap denoting the approximate cap location and requesting RACER be contacted prior to accessing or performing work in the area of the soil cap on December 1, 2017
- Completed field activities for the 1,4-D Quarterly Supplemental Scope of Work (sampling/gauging) the week of July 17<sup>th</sup>, 2017 (event 2 of 4) and the week of October 23<sup>rd</sup>, 2017 (event 3 of 4).
- Submitted the 2017 1,4-Dioxane Supplemental Investigation Memo to USEPA on December 7, 2017.
- Parcel 14-20-276-001 well abandonment activities were completed the week of July 17<sup>th</sup>, 2017. The Well Abandonment Summary was submitted to USEPA on November 21, 2017.
- The 2016 Annual Groundwater Monitoring Addendum, which included results from additional vinyl chloride analysis in the former Plant 25 area, was submitted to USEPA on July 31, 2017.
- The 2017 annual groundwater monitoring event was completed the week of October 23<sup>rd</sup>, 2017
- Submitted Montcalm Seep IM Work Plan to USEPA/MDEQ on November 10, 2017. Completed injection testing activities as specified in the IM Work Plan, including the installation of one injection well, during December 2017.
- Continued support and coordination with existing property owners.

- Complete 1,4-Dioxane sampling activities (quarterly well sampling in January).
- Complete and submit 1,4-Dioxane sampling data memo.
- Prepare site-wide well abandonment proposal.
- Support final decision process.
- Respond to any comments received from USEPA or MDEQ on submittals or other matters.
- Prepare and submit any needed budget amendments.
