In accordance with requirements of the above referenced Consent Order, we are providing you with this Monthly Status Report for the month of August 2009.

1. Work Completed This Reporting Period

- Dewatering of the leak detection vaults occurred on August 13, 2009.
- Samples were collected from the accumulation tank and analyzed to verify compliance with the Sewer Use Permit issued by the City of Flint and the Beecher Metropolitan District.
- Landfill cap inspection occurred on August 26, 2009.

2. Summaries of Findings

• During landfill cap inspections, approximately 80 of trees and shrubs were removed and traps were set over active animal burrows.



9. Reports/Data

• Leak detection Vaults A, B, C, D, E and F were pumped on August 13, 2009. During August 2009, no water was removed from Vaults A, and D. However, 92 gallons were removed from Vault B, 89 gallons were removed from Vault C, 268 gallons were removed from Vault E, and 45 gallons were removed from Vault F. Total volume of water removed from the vaults during the month of August was 574 gallons (including rinse water). According to the master flow meter, a total of 1,482 gallons were discharged to the accumulation tank; therefore, 908 gallons were pumped from the sumps during the month of August 2009.
