Sanitary Sewer Investigation

On behalf of Revitalizing Auto Communities Environmental Response (RACER) Trust, Arcadis of Michigan, LLC (Arcadis) has prepared this work plan as part of the ongoing sanitary sewer per- and polyfluoroalkyl substances (PFAS) investigation at the RACER Buick City Site in Flint, Michigan. Arcadis is proposing additional sewer sampling at MH D, located along James P. Cole Boulevard, and upgradient of MH D. Previous sampling results at MH D show concentrations of Perfluorooctanesulfonic acid (PFOS) above the Michigan Department of Environment, Great Lakes, and Energy (EGLE) Groundwater-Surface Water Interface (GSI) Criteria (12 nanograms/liter). The purpose of this sampling is to evaluate if there are areas of the Site or adjacent properties that may be contributing PFAS to the sanitary sewers.

Scope of Work

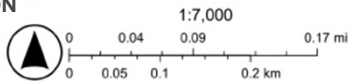
Figure 1 – Southend Sample Locations

As discussed during the September 9, 2025 monthly call with EGLE, RACER proposes to conduct additional sampling activities along James P. Cole Boulevard and upgradient areas. Arcadis will collect samples from select sanitary sewer manholes for PFAS analysis beginning at manhole location MH D, and five manholes upgradient, including MH C-4, MH A-3, MH A, MH AA-5, and MH AA-2 (**Figure 1 and Figure 2**). Samples will be collected using a peristaltic pump with weighted tubing to collect flow coming into the manhole. If there is no flow into the manhole, a sample will not be collected. PFAS sampling will be completed in accordance with the Buick City *Field Sampling Plan* submitted to EGLE in May 2023. Samples will be submitted under chain of custody to ALS Laboratory Group located in Holland, Michigan for analysis of PFAS compounds via method ASTM-D7979. One duplicate sample will be collected for quality control purposes.

Arcadis will subcontract Give Em' A Break Safety to provide traffic control for the manholes located within roadways for safety protection while accessing each of the manholes.

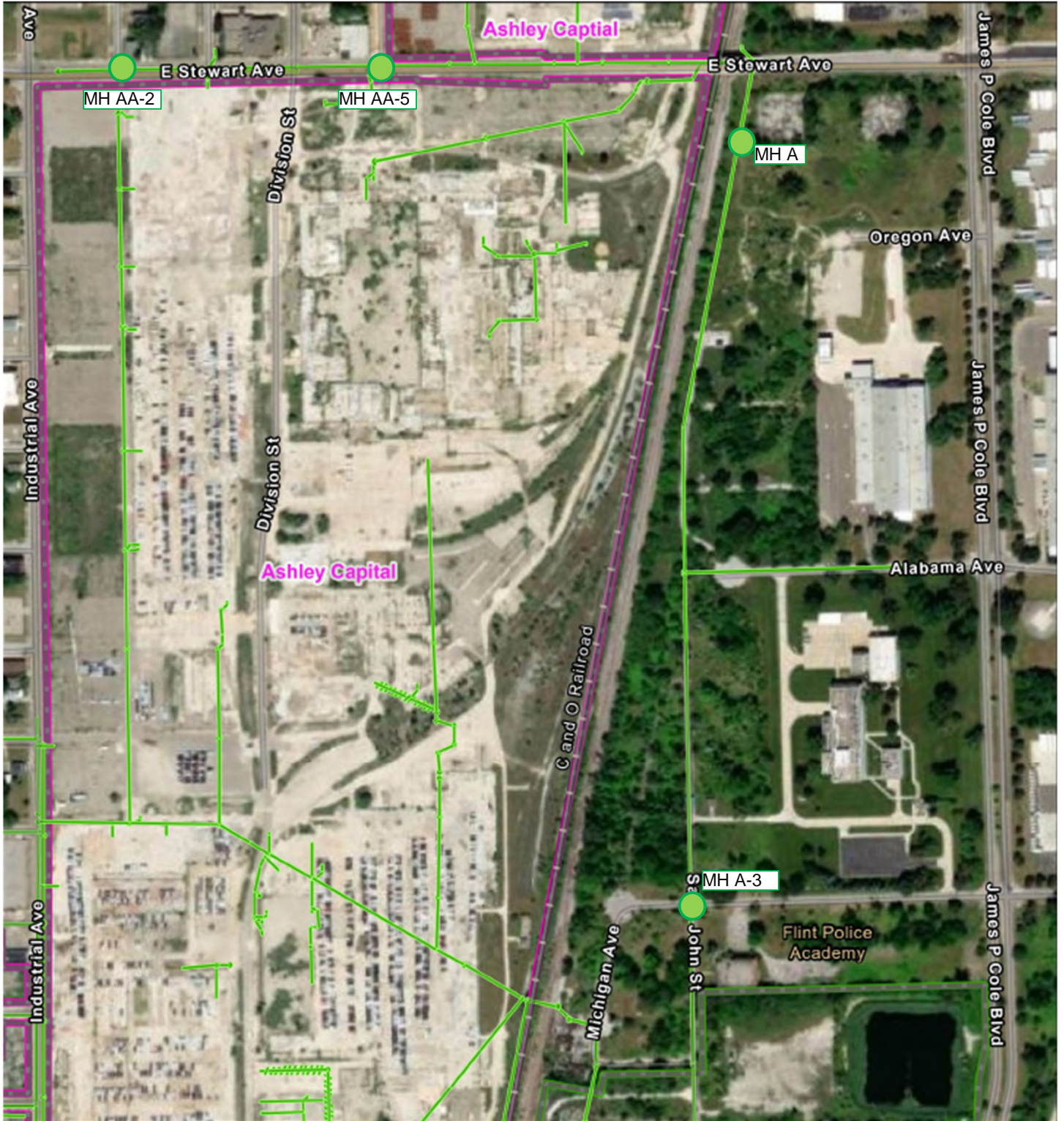

SOUTHEND SAMPLE LOCATIONS

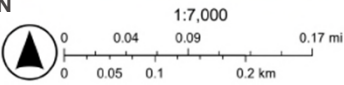
