The Michigan Department of Environmental Quality (MDEQ), Environmental Response Division, has reviewed the January, 1998 Closure Report for Residential Properties of the Windiate Park/Dixieland Subdivision Landfill site, prepared by O'Brien & Gere Engineers, Inc. (OBG), for a land use based remedial action plan pursuant to Part 201 of the Natural Resources and Environmental Protection Act (NREPA), 1994 PA 451, as amended, MCL 324.20101, et seq. Based on our evaluation of the report, the MDEQ concurs that the above referenced properties meet the criteria for a Generic Residential Closure and closure has been approved.

Please be advised that closure for the two Limited Residential properties addressed in the January, 1998 Closure Report for Residential Properties will be addressed under separate cover.
