Dear Mr. Runge:

In accordance with requirements of the approved Post-Closure Care Plan, we are providing you with this Quarterly Status Report for the third quarter 2021 for activities related to post-closure care for the landfill. The status of on-going Site characterization and interim measures are not included in this report.

1. Work Completed This Reporting Period

- » Dewatering of the leak detection vaults occurred on July 15, 2021 (Vault E), August 19, 2021, and September 14, 2021.
- » The semiannual Groundwater Monitoring, Sump, and Leak Detection System (LDS) monitoring reports were submitted to EGLE on August 18, 2021.
- » Annual inspection and split sampling with the City of Flint, Department of Public Works and Utilities Water Pollution Control occurred on August 25, 2021.
- » Sampling of accumulated liquids was conducted on August 25, 2021. The results will be presented in the third quarter 2021 Periodic Report on Continued Compliance (PRCC) due to the City of Flint on or before October 28, 2021 and will be provided to you via email.
- » Discharge of liquids from the accumulation tank occurred on September 14, 2021 through September 16, 2021. A total of 6,977 gallons were discharge during this quarter. Breakthrough and compliance samples were collected from GAC vessels, and the analytical results will be presented in the third quarter 2021 PRCC.
- » Mowed the grass around building and along Site roads on August 25, 2021 and August 26, 2021.
- » The third quarter 2021 site inspection occurred on September 28, 2021 and September 29, 2021.

5. Summaries of all Problems

- » The protective casing for monitoring wells OBG-MW-21 and OBG-MW-19D were damaged during the construction of the stormwater berm.
- » Discharge meter for the accumulation tank stopped calculating the flow during the 2nd quarterly discharge.

6. Actions Being Taken to Rectify Problems

- » Job Site Services repaired the protective casing for monitoring wells OBG-MW-21 and OBG-MW-19D on September 27, 2021.
- The internal components of the accumulation tank discharge meter were replaced on September 14, 2021 prior to the 3rd quarter discharge. The discharge meter is now functioning properly.

7. Changes in Personnel

» None.

8. Projected Work

- » Dewatering of the leak detection vaults is scheduled for October 13, 2021, November 17, 2021, and December 15, 2021.
- » Sampling and discharge of accumulated liquids will be conducted as needed.
- » The annual Groundwater Monitoring, Sump, and Leak Detection System (LDS) monitoring is scheduled for November 2021.
- » The fourth quarter 2021 site inspection will be conducted in December 2021.



Total volume of water removed from the vaults during the third quarter was 5,673 gallons. According to the master flow meter and discharge records, a total of 3,606 gallons were pumped from the sumps during the third quarter.
