
In 1984 a portion of the Corps' regulatory responsibilities was assumed by the Michigan Department of Environmental Quality (MDEQ). This project site is within the assumed area. Unless otherwise notified, a separate authorization from the Corps is not required; however, you may need to obtain a permit from the MDEQ. Therefore, we recommend that you contact MDEQ, Saginaw Bay District office at (989) 894-6200 for a determination of State permit requirements.
